Prospects in Hampshire

As you are now aware, Hampshire County Council commissioned Prospects to support all childminders and targeted group settings in Hampshire, and we have been doing just that, since the 1 of April 2015. We are commissioned to support in specific ways:

- All childminders with an Ofsted grading of Inadequate, Requires Improvement, Satisfactory or Not Met. We do this through phone and emails, visits, by invitation to daytime Quality Practice and Play Sessions (QPPS), at evening workshops and webinars.
- Newly registered childminders awaiting their first Ofsted inspection, through email and phone
 contact, a visit, invitations to join us at events such as QPPSs, evening workshops and
 webinars.
- Childminders who are approved to take EYE funding for 2, 3 and 4 year olds, regardless of their Ofsted outcome; we do this by managing the headcount process for EYE childminders, 3 times a year. We also offer a termly 'EYE Provider Briefing' which can be attended by any EYE registered provider, regardless of the last time you made an EYE claim.
- EYE approved childminders will now also take part in a compliance review, HCC require us to undertake compliance reviews on 10% of all claiming EYE providers, chosen at random.
- Group providers with an Ofsted grading below good, and with actions around leadership and management or welfare requirements of the EYFS Statutory Framework, or who have been targeted for specific support.
- All committee-run providers, supporting committees through webinars and, where the need arises and agreed with SfYC, through visits and 1:1 support to committees.
- General peer support and discussion is available to all providers both childminders and group providers (owners, staff, committee members), via our Prospects Facebook Group (https://www.facebook.com/login.php?next=https%3A%2F%2Fwww.facebook.com%2Fgroups%2F384551638384221%2F) which is only for Hampshire. We will check that you are a registered childminder or group practitioner and will only approve your request to join, once we are satisfied.

What's happening this term?

We have a variety of free webinars, as well as Quality Practice and Play sessions, and workshops. Most of our events are targeted at a specific audience.

Staff supervision meetings – Childminders employing assistants and group settings

In accordance with the Statutory Framework for the Early Years Foundation Stage 2014, staff supervision is a requirement for providers:

3.21 Providers must put appropriate arrangements in place for the supervision of staff who have contact with children and families. Effective supervision provides support, coaching and training for the practitioner and promotes the interests of children. Supervision should foster a culture of mutual support, teamwork and continuous improvement, which encourages the confidential discussion of sensitive issues.

3.22 Supervision should provide opportunities for staff to:

- discuss any issues particularly concerning children's development or well-being;
- identify solutions to address issues as they arise; and
- receive coaching to improve their personal effectiveness.

Things to put in place: How do you organise supervision within your setting? Is it a regular planned feature for all staff members?

Who carries out the supervision of the manager? In a committee-run setting who will undertake this? In a group owned or private sole trader with staff who will undertake the manager's supervision meetings and will the manager cascade similar process to other staff leads.

Now is the time to make sure you have put in place a good supervision structure to meet EYFS and ensure that accountability and responsibility is clear. Take time to review your supervision processes and have a discussion with your committee/business owner to ensure they know their responsibilities.

Childminders remember: If you have staff working with you (paid or unpaid), you must carry out supervision with them as part of the requirements of EYFS.

Pass It On update
